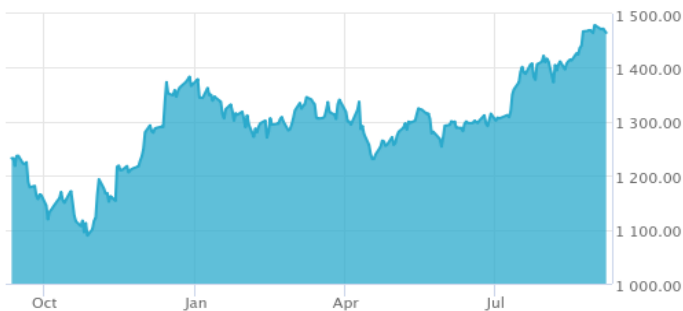

At least 250,000 shares traded per month over the last six months at a review and also at the previous two reviews. For preferred stocks: Full MCap of at least 75 mln USD. At least 200,000 shares traded per month over the last six months at the current index review.

#### Universe

Companies have to be included in the iREIT Equity REIT-100 universe.

#### Diversification

Components are weighted equally with a tilt toward stocks selected in the Higher Quality REITs bucket.
