Full MCap of at least 150 mln USD. Three month average-daily-trading volume of at least 1 mln USD at a review and also at the previous two reviews. At least 250,000 shares traded per month over the last six months at a review and also at the previous two reviews.

### Pure-Play

Index includes Indian companies involved in the technology, electronic commerce, and telecommunications sectors.

#### Diversification

Company weightings are capped at 8%.







