
COIN50 Daily Summary

The COIN50 index experienced a daily return of -5.44%. The return of Smart Contract Platforms category was a significant -6.98%. The 30-day trend showed a modest gain of 5.48%, whereas the 90-day trend indicated a positive return of 54.39%.

- 1. **Top Performer:** ZCash showed a positive return of 3.66%.
- 2. **Largest Decline:** Uniswap Protocol Token suffered the most, with a return of -14.49%.
